How we handle any personal data you give us

What data do we collect?

Registered users:

- Name and/or company name
- Email address

Trusted Members: When you become a Trusted Member of Let's Trade Rooms, we request the data below. This list includes some mandatory data which we request from you, in addition to optional data, for the promotion of your services and for accounting purposes.

- Name and/or company name
- Email address
- Country
- City/Address

- TAX number
- Billing address

Where is it stored?

All data is stored on our secure servers based in the United Kingdom.

What do we do with this information?

Send you relevant information about hotel availability for global sports events (our INVENTORY GRID) and help you buy or sell hotel rooms for these sports events.

IP addresses and Cookies

IP address is stored temporarily for security and spam prevention. letstraderooms.com uses cookies to store visitors' preferences, record session information, record user-specific information on what pages users access or visit, record past activity at a site in order to provide better service when visitors return to our site, customize Web page content based on visitors' browser type or other information that the visitor sends.

Cookies are text files that are either temporarily stored in the random access memory or on the hard drive of your computer. They generally serve for offering you the services of productionparadise.com within your personal settings of each new session, which basically means to give you a better and faster experience more in tune with what you like to see. Cookies are partly stored permanently on your hard drive. You may prevent this by setting your browser accordingly, however you may notice that our website does not run as fast and in the same way to what you would expect.

Technical security
